



Chuck Heindrichs noted for the month of February, contributions were less than \$15,000, \$2,500 less than our projected budget of \$17,500. Secondly, the Organ Fund contributions have been steadily decreasing over the past two months. Instead of \$475/month, we are currently at \$365/month

Tim Gottshall reported there was no Property Committee meeting in February. Sue Frantz has contacted tree companies, and Tim will have that information available soon. One HVAC unit has stopped working, and are awaiting recommendations. It is one of the remaining that needs to be replaced.

Pastor Laura met with all the preschool teachers individually. She wanted to get to know them a little better and hear their thoughts regarding the preschool. The biggest take away she got was their admiration for the director, Teri Pienoski.
